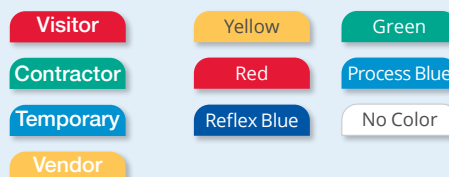

# PRECAUTION LABELS

## Contact Precautions

(In addition to Standard Precautions)

### Visitors — Report to Nurses' Station Before Entering Room

- Private Room.** When a private room is not available, cohort with patient(s) who has active infection with the same microorganism but with no other infection.
- Wear gloves when entering room.** Change gloves after contact with infective material. Remove gloves before leaving the patient's room.
- WASH YOUR HANDS** immediately with antimicrobial agent before leaving the patient's room. After glove removal and handwashing, ensure that hands do not touch potentially contaminated environmental surfaces or items in the patient's room to avoid transfer of microorganism to other patients or environments.
- Wear a gown** if you anticipate that your clothes will have substantial contact with the patient, environmental surfaces, or items in the patient's room or if the patient has any of the following:
  - Incontinent • Diarrhea • Colostomy • Ileostomy
  - Wound Drainage not contained by a dressing
- Remove gown before leaving patient's environment.
- Limit the movement/transport of patients from room to essential purposes only. During transport, ensure that all precautions are maintained at all times.
- When possible, dedicate the use of noncritical patient care equipment for each patient.

## Precauciones de Contacto

(además de Precauciones Normales)

### Visitantes — Favor de Reportarse a la Estación de Enfermeras Antes de Entrar al Cuarto

- Cuarto Privado.** Cuando el cuarto privado no esté disponible, se comparte el cuarto con paciente(s) que tenga(n) una infección activa con el mismo microorganismo pero sin cualquier otra infección.
- Usar guantes al entrar al cuarto.** Cambiarse los guantes después de tener contacto con sustancias infecciosas. Quitese los guantes antes de salir del cuarto del paciente.
- LAVARSE LAS MANOS** inmediatamente con detergente antimicrobico antes de salir del cuarto del paciente. Después de quitarse los guantes y de lavarse las manos, asegurese de que sus manos no toquen superficies o artículos potencialmente contaminados dentro del cuarto del paciente para evitar transmitir el microorganismo a otros pacientes o medio ambiente.
- Use una bata si anticipa que su ropa tendrá contacto con el paciente, superficies del ambiente, o artículos en el cuarto del paciente, o si el paciente tiene cualquiera de lo siguiente:
  - Incontinencia • Diarrea • Colostomía • Ileostomía
  - Drenaje de herida no cubierta por un vendaje
- Quitarse la bata antes de salir del cuarto del paciente.
- Limitar el movimiento/transporte de pacientes del cuarto solo para propósitos esenciales. Durante el transporte, asegurarse que todas las precauciones sean obedecidas en todo momento.
- Cuando posible, asigna equipo individual para cada paciente.

## CONTACT PRECAUTIONS

(In addition to Standard Precautions)

### Visitors — Report to Nurses' Station Before Entering Room

- Private Room** - when private rooms are in short supply, prioritize patients with conditions that may facilitate transmission and cohort with patient(s) who has active infection with the same microorganism but with no other infection. Maintain spatial separation of at least 3 feet from other patients and visitors and draw privacy curtains if cohorting or private room is not available.
- Gloves and Gown** - wear gloves and gown when entering room or cubicle. Remove gown and gloves before leaving patient's room and ensure that clothing and skin do not contact potentially contaminated environmental surfaces that could result in possible transfer of microorganisms.
- Wash Hands** - with warm water and antimicrobial agent immediately after glove and gown removal and before leaving patient's room.
- Transport** - limit the movement and transport of patients outside the room to medically necessary purposes only. If transport is essential, ensure infected areas of the patient's body are contained and covered.
- Equipment** - use disposable non-critical patient-care equipment (e.g. blood pressure cuffs) or implement patient-dedicated use of such equipment. If use of common equipment is unavoidable, clean and disinfect equipment between patients.
- Environmental Measures** - Ensure that rooms of infected patients are prioritized for frequent cleaning and disinfection (e.g. at least once daily) with a focus on frequently touched surfaces (e.g. bed rails, overbed table, doorknobs) and equipment in the immediate vicinity of the patient.

### Visitors — Report to Nurses' Station Before Entering Room

- Private Room** - When a private room is not available, cohort with patient(s) who has active infection with the same microorganism but with no other infection.
- Gloves** - wear gloves when entering room. Change gloves after contact with infective material. Remove gloves before leaving the patient's room.
- Wash Hands** - with antimicrobial agent immediately after glove removal and before leaving patient's room.
- Gown** - wear when entering room to protect clothes from items in the patient's room or if the patient has any of the following: • Incontinent • Diarrhea • Colostomy • Ileostomy • Wound Drainage not contained by a dressing  
Remove gown before leaving the patient's environment.
- Transport** - Limit the movement/transport of patients from room to essential purposes only. During transport, ensure that all precautions are maintained at all times.
- When possible, dedicate the use of noncritical patient care equipment to a single patient. If common equipment is used, clean and disinfect between patients.



These steps are recommended by the CDC to reduce the risk of transferring microorganisms through direct contact with a patient. The signs are placed outside the patient's door to warn visitors and staff of necessary steps to reduce the spread of disease.

## Droplet Precautions

(In addition to Standard Precautions)

### Visitors — Report to Nurses' Station Before Entering Room

- 1. Private Room.** When a private room is not available, cohort with patient(s) who has active infection with the same microorganism but with no other infection. Maintain spatial separation of at least 3 feet from other patients and visitors if cohorting or private room is not available.
- 2. Mask** required when working within 3 feet of patient (or when entering room). Check your hospital's policy.
- 3. Limit** the movement/transport of patients from room to essential purposes only. During transport, **minimize the spread of droplets by placing a surgical mask on the patient, if possible.**

### Visitantes — Favor de Reportarse a la Estación de Enfermeras Antes de Entrar al Cuarto.

- 1. Cuarto Privado.** Cuando el cuarto privado no esté disponible, se comparte el cuarto con paciente(s) que tenga(n) una infección activa con el mismo microorganismo pero sin cualquier otra infección. Mantener una distancia de por lo menos 3 pies de otros pacientes o visitantes si comparten un solo cuarto, o cuando un cuarto privado no está disponible.
- 2. Máscara** requerida cuando esté trabajando dentro de 3 pies del paciente (o al entrar al cuarto). Verifique los reglamentos del hospital.

- 3. Limit** the movement/transport of patients from room to essential purposes only. During transport, **minimize the spread of droplets by placing a surgical mask on the patient, if possible.**

### Visitors — Report to Nurses' Station Before Entering Room

#### 1. PATIENT PLACEMENT

**Private Room.** When a private room is not available, cohort with patient(s) who has active infection with the same microorganism but with no other infection. Maintain spatial separation of at least 3 feet from other patients and visitors if cohorting or private room is not available.



#### 2. RESPIRATORY PROTECTION

Mask required when working within 3 feet of patient (or when entering room). Check your hospital's policy.



#### 3. PATIENT TRANSPORT

Limit the movement/transport of patients from room to essential purposes only. During transport, **place surgical mask on the patient, if possible.**
